



The PNHS 2024 Official Poster / Program Art Contest **ENTRY / RELEASE FORM**

- Submit a colorful representation of any aspect of the Pennsylvania National Horse Show (PNHS). The winning entry will be featured on both the Official 2024 PNHS Poster and the cover of the Official 2024 PNHS Program.
- DEADLINE for entry submissions is July 8, 2024.
- For judging purposes, initial contest submissions should be a digital, emailed photo (to Shelly@PAnational.org). One submission per entry/person. A short description of the art and artist should accompany the submission. **Please include information about the size and type of artwork and equestrian background of the artist, and any additional interesting information you may want to include.
- This entry form includes a PNHS "Artwork Release Form" (page 2) which must be submitted with your entry.
- Winners will be chosen by a closed panel of judges, based on:
 1. Creativity, uniqueness, and originality, especially as it relates to PNHS
 2. Quality of artistic composition and overall design
 3. Color and tone
 4. Overall impression of the art
- One Grand Prize of \$1,000 will be awarded. Four (4) Honorable Mention entries will also receive awards and be featured in the 2024 PNHS Official Program. Winners will be announced July 24, 2024.
- Grand Prize Winning entry's original artwork to be submitted in high-resolution, digital format to Pennsylvania National Horse Show Foundation (PNHSF) no later than August 16, 2024, and becomes the property of PNHSF.

The PNHS 2024 Official Poster / Program Art Contest Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

- Entry Period: The Contest ("Contest") will begin on March 18, 2024 at 12:01 AM and ends on July 8, 2024 at 11:59 PM Eastern ("Entry Period").
- Agreement to Official Rules: Participation in the Contest constitutes Entrant's full and unconditional agreement to these Official Rules, and Sponsor's decisions, which are final and binding in all matters related to the Contest. Winning is contingent upon fulfilling all requirements set forth herein.
- Sponsor: The Contest is sponsored and administered by Pennsylvania National Horse Show Foundation ("Sponsor").
- Eligibility: The Contest is open and offered only to individuals age 18 and older that reside in the United States including the District of Columbia. Employees, officers and directors of Sponsor and their parents, affiliates, subsidiaries, divisions, advertising, promotional, fulfillment and marketing agencies, their immediate families (including parents, children - whether step children or adoptive children or biological children - siblings, spouses and in-laws), and persons living in the same household (whether related or not) are not eligible to participate in the Contest. Void where prohibited or restricted by law, rule or regulation.
- How to Enter: Enter the Contest by submitting original artwork consisting of a colorful representation of any aspect of the Pennsylvania National Horse Show ("Your Submission"). Your Submission should be transmitted to Sponsor during the Entry Period by sending a digital photo of the artwork via email to Shelly@PANational.org. One submission per person. A short description of the art and artist should accompany the submission. Submissions must include information about the size and type of artwork and equestrian background of the artist, and any additional interesting information you may want to include. The Grand Prize winner must submit the winning original artwork in high-resolution digital format to the Sponsor no later than August 16, 2024.
- Previous submissions are not eligible for the 2024 PNHS Art Contest.
- By entering the Contest and submitting an entry, you grant Sponsor a royalty-free, non-exclusive irrevocable license to display, modify, create derivatives of, publish and otherwise use Your Submission in any and all mediums throughout the world and the universe without any obligation of attribution. To be eligible, Your Submission must be your original work and must not infringe or violate the rights of others. By entering the Contest and submitting Your Submission, you represent and warrant that Your Submission is your original work and that you took the photograph submitted. By submitting Your Submission, you further represent and warrant that Your Submission does not violate or infringe on another person's rights, including, but not limited to, privacy, publicity, copyright, trademark or other intellectual property right. Entries that in Sponsor's sole judgment contain objectionable or inappropriate content are ineligible. Sponsor shall determine the eligibility of Your Submission in their sole and absolute discretion. Sponsor may use Your Submission in connection with internal and external communications materials including but not limited to websites, advertising, and other promotional materials.
- All entries must be received during the Entry Period. Incomplete entries, or those containing incorrect information, will be void. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Use of any automated system to submit entries is prohibited and will result in disqualification of all such entries as well as the Entrant. All original copies of Your Submission become the property of Sponsor and may not be acknowledged or returned.
- Prizes & JUDGING: One Grand Prize of \$1,000 will be awarded. Four (4) Honorable Mention entries will also receive awards and be featured in the 2024 PNHS Official Program. Top winners artwork will be featured in the 2024 Pennsylvania National Horse Show Official Program and the Grand Prize winner will also be featured on a Pennsylvania National Horse Show poster. All submissions will be judged by a panel of judges chosen by Sponsor on the following criteria: (1) creativity, uniqueness, and originality, especially as it relates to PNHS; (2) quality of artistic composition and overall design, (3) color and tone; and, (4) overall impression of the art.
- Notification of Winners: Winners will be announced on July 24, 2024. Each winner will be notified by Sponsor at the email address and phone number provided in the entry.
- In the event of noncompliance with the Official Rules, if a potential winner cannot be reached through the contact information provided with winner's entry or if the prize or prize notification is returned as unclaimed or undeliverable, an alternate winner will be selected.

- **LIMITATIONS OF LIABILITY:** Employees, officers and directors of Sponsor, Judges and their respective parents, affiliates, subsidiaries, divisions, advertising, promotional, fulfillment and marketing agencies (collectively the “Released Parties”) shall not be responsible for: (1) any incorrect or inaccurate information, whether caused by any Entrant, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) technical or human error which may occur in the administration of the Contest or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from Entrant’s participation in the Contest or receipt or use or misuse of any prize. Sponsor is not responsible for misdirected or undeliverable entries or for any technical problems, malfunctions of computer systems, servers, service providers, hardware/software, lost or unavailable network connections or failed, incomplete, garbled or delayed computer transmission or any combination thereof. Sponsor is not responsible for any typographical or other errors in entries, selection announcement or for any liability for damage to any computer system resulting from participation in, accessing or downloading information in connection with this promotion. In the event Sponsor is prevented from awarding prizes or continuing with the Contest as contemplated herein by any event beyond its control, including but not limited to fire, flood, natural or man-made epidemic of health or other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal, state or local government law, order or regulation, public health crisis, order of any court or jurisdiction, or other cause not reasonably within Sponsor’s control (each a “Force Majeure” event or occurrence), then Sponsor shall have the right to modify, suspend or terminate the Contest. Sponsor’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

- **Other Terms & Conditions:** CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR AND ADMINSTRATOR RESERVE THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH PERSON(S) RESPONSIBLE FOR THE ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW. The Contest is subject to all applicable federal, state, and local laws. In the event of a dispute regarding the identity of an individual who submitted an entry, the entry will be deemed submitted by the authorized account holder of the phone number or email account associated with the entry or through which the entry was submitted. “Authorized account holder” shall be defined as the natural person who is assigned to an email account or phone number by the respective service provider. Selected winner may be required to show proof of being the authorized account holder. Sponsor reserves the right, in its sole discretion, to disqualify any entry and to modify, terminate or suspend this Contest should virus, bugs, non-authorized human intervention, action of entrants, or other causes beyond the reasonable control of Sponsor corrupt or impair the administration, security, fairness or proper play of the Contest and, if the Contest is modified, terminated or suspended, at Sponsor’s discretion, select winners from those eligible, non-suspect entries. Winners further acknowledge that the Released Parties have neither made nor are in any manner responsible or liable for any warranty, representation or guarantee express or implied, in fact or in law, relative to the Contest or any prize, including, but not limited to, its quality or fitness for a particular purpose.

- **Personal Data:** Sponsor will collect personal data about entrants including e-mail addresses associated with entries. By participating in the Contest and providing your personal information, entrants hereby agree to Sponsor’s collection and usage of their personal information provided.

- **Disputes:** Except where prohibited, you agree that any and all disputes, claims and causes of action arising out of, or connected with, the Contest or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the Commonwealth of Pennsylvania. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the Commonwealth of Pennsylvania, without giving effect to any choice of law or conflict of law rules (whether of the Commonwealth of Pennsylvania or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the Commonwealth of Pennsylvania.
